Nurturing growth by sparking curiosity and fostering a sense of belonging.

WE WELCOME ALL.

Goal 1: We provide a welcoming and inviting space for dialogue and personal connections.

- On September 19, fifteen community members met visiting language instructor Marie-Ange Andrieux, from Thionville, France, Urbana's Sister City. This event celebrated the foreign language exchanges between the advanced French class of Ms. Lynda Lopez at Uni High School in Urbana and the English language classes of Mme. Andrieux. This partnership received the "Champion of Youth" Award for 2022 by the Illinois Sister Cities Association. *The program was sponsored by the Urbana Sister Cities Program.*
- An appeal letter from Cunningham Children's Home is included in the Board packet, which highlights some of the benefits of the work done in the Teen Open Lab and demonstrates the importance of the partnerships the Library has cultivated over the years in serving youth in our community. From developing graphics to advertise teen programs, to staffing the TOL, to setting up and taking down the TOL four days a week, to smiling at teens as they walk past the service desks, creating a safe and welcoming environment for them to be, so many staff participate in making the Library and the TOL a place kids want to be, and I hope you enjoy seeing this example of how our work matters to the community.

Goal 2: We engage the community to understand and respond to unique needs of our community.

- September was Library Card Sign Up Month. To celebrate, those who signed up for a library card in September could enter a raffle to win a 39" Smart HD Fire TV. Over 250 new library cards were issued in September, and 86 community members entered the raffle. The Library also encouraged library card signup at ten different outreach events, including school open houses, USD#116's new teacher resource fair, and CU Pride Fest's Youth and Family Party and Pride Fest. Staff spoke with over 200 community members at these events.



We connect people with tools and resources for learning and leading fruitful lives.

WE SPARK CURIOSITY.

Goal 1: We connect people to resources and technology for personal growth leading to greater fulfillment.



• Mark Roberts, local author and creator of the TV show *Mike and Molly*, generously gifted the Library copies of his newest works of illustrated humorous poems, *The Bad Mule Rag* newspaper and *The Lonely Banjo* book, to give away. On September 30, the Library cosponsored Mr. Roberts' free reading of *The Bad Mule Rag* to a full house at the Cohen Building.

- Therapy dogs Eli, Dixie, Snow, and Willow listened to stories from 45 community members during September's Read to the Dogs. The program encouraged young readers to practice their reading skills and to enjoy reading to patient, nonjudgmental furry friends. *Presented in partnership with Canine Connection, a local pet therapy organization.*



Goal 2: We expand horizons and facilitate knowledge exchange by offering diverse programs.

- Can you spell jurisprudence? That was the winning word for Susan Bekaires at the Library's Adult Spelling Bee on September 17. Our amazing participants also successfully spelled xylograph, lackadaisical, and corpuscle among other difficult words.



- The children's area transformed into a putting obstacle course on September 24 for Mini Golf at the Library. Community members were encouraged to design their own golf hole for the program and test their putting skills on other holes. The challenge was accepted by 40 community members who maneuvered around or through obstacles like stuffed animals, giant blocks, and more!
- A memo on the Summer Reading program is included in the Board packet.




We help our community thrive by creating connections and working with partners.

WE CONTRIBUTE TO A STRONG SOCIAL FABRIC.

Goal 1: We make the community better for all by promoting diversity, equity and inclusion through our collections and programs.

- As part of Pygmalion on September 22, the Library hosted a reading and book signing with mystery author Mia P. Manansala. Manansala read the first chapter from her book *Arsenic and Adobo*. She also discussed why cozy mysteries are rom-coms with dead bodies, how her Filipino-American identity impacts her works, and how she constructs her books. After the discussion, many of 21 community members at the event (who were not at the first ever Thursday night Illini football game) met the author and had a book signed. *This event was generously funded by The Urbana Free Library Foundation.*
- September's Illinois Libraries Present program celebrated Deaf Awareness Month with a conversation between Academy Award winning actress Marlee Matlin, with her ASL interpreter, and fellow deaf actor Richard Costes. They discussed the impact books and libraries had on them while they were growing up, the importance of finding a mentor, and shared advice on advocating for yourself. The live discussion was observed by 24 people from our Library. *This event is made possible by Illinois Libraries Present, a statewide collaboration among public libraries offering premier events.*



Goal 2: We stimulate connections and partnerships to create a vibrant, engaged community.

- The Library worked with community partners to host three programs for Welcome Week, which celebrates immigration, community, and inclusivity. The 9th Annual Immigrant Welcome Awards, sponsored by C-U Immigration Forum with multiple co-sponsors, honored the efforts of several individuals, businesses, and organizations for their work with immigrant communities. Winners included Gloria Yen, a former Library employee and current Library Board member, for her work as the Director of the New American Welcome Center and the New American Welcome Center, with which the Library regularly partners. The League of Women Voters registered people to vote at this event. UFLive! featured music by Bourema "Ibrahim" Ouedraogo and Jason Finkelman, with music inspired by Ouedrago's origins in Burkina Faso, West Africa. After the concert, the Immigration Project held a cake walk in Cherry Alley and shared information about their services. Altogether, almost 150 community members attended Welcome Week events at the Library. *UFLive! concerts are made possible with the generous support of The Urbana Free Library Foundation.*

We are mindful of the wide array of resources needed to serve evolving community needs and are transparent with our operations.

WE ARE A STRONG ORGANIZATION.

Goal 1: We steward our physical and financial resources to allow for growth and sustainability.

- Library IT has enhanced our cybersecurity by installing CrowdStrike, an Endpoint Detection and Response (EDR) software, on our workstations. This was accomplished for free, thanks to the State adding us to their tenancy.
- Because of space limitations in staff offices, staff moved paper and a copier, shuffled tables and desks, and took down shelving, to create a work space in the Administration offices for Kirstin Gebhart, the new Communications & Development Manager.
- Fred Schlipf & Celeste Choate had conversations with a small number of community members, including teens, and received written suggestions from others, about how the Library building works or does not work well for them. Fred and Celeste will also be meeting with Library staff this week, and will facilitate a conversation with the Library Board on this topic at the October Board meeting.
- The Friends of the Library had a successful book sale in August, raising just over \$2,800. This revenue helps the Library purchase books and reading program prizes.

Goal 2: We cultivate continuous improvement among Board and staff members to create increased engagement, satisfaction, and retention.

- Library staff member Elaine Bearden was invited to take part in this year's CU Folk and Roots Festival. Elaine will be one of the storytellers featured at the Library on October 22.
- Carol Inskeep was asked to speak at the Museum of the Grand Prairie's Stakeholders Meeting on October 6. Carol discussed how the organizations have partnered on programs over the last few years. Partnerships have included the crafting program Healing Arts, a discussion on the history of victory gardens in Champaign County, and an exploration of what it was like to be a student in a one room schoolhouse.

- This month, we bring you a brand-new policy: Americans With Disabilities Act (ADA). We have always adhered to the ADA, but best practice is to codify it into policy. Staff recommends that the Board adopt this new policy.

Employees or applicants with disabilities who believe they require a reasonable accommodation to apply for a position or to perform the essential function of their job should contact their supervisor and/or the Associate Director or their designee.

4. COMPLAINTS

The Executive Director or their designee will investigate any complaint against the Library regarding the ADA. Employees should raise concerns about the ADA with the Associate Director or their designee. Persons who are dissatisfied with the determination regarding their complaint may contact the Executive Director.

5. RETALIATION ABSOLUTELY PROHIBITED

The Library will not coerce, intimidate, threaten, harass, or interfere with any individual exercising their rights under the ADA or because the individual aided or encouraged any other individual in the exercise of rights granted or protected by the ADA.



Architectural Firm Selection Process

October 11 Board Meeting: Celeste will outline the architectural services selection process and timeline for the Board and ask for any interested Board members to join staff (i.e., Celeste, Dawn, Mike, Rachel, Gretchen) in evaluating submissions and narrowing the number of firms invited to present to the Board.

October 28: Deadline for Architectural RFQ submissions.

November 4: Deadline for Dawn to complete reference checks and forward compiled information to evaluators to use while doing their evaluations.

November 11: Evaluation forms due to Dawn for tallying.

November 14: Invitations sent to 3-4 selected firms to present to the Board along with invitation to tour UFL and see the areas to be remodeled.

Week of December 5-9: Special Board Meeting to be held to interview architectural firms (probably 6-9 p.m.).

- 20 minutes per firm for prepared presentation.
- 15 minutes per firm to take Board questions.
- Then, brief Board discussion to wrap up the meeting—but no decisions made.

December 13 Board Meeting: Board votes to select a firm.

- Ask each Board member to verbally rank firms from favorite to least favorite.
- Add up rankings and narrow to top 2 firms.
- Ask each Board member to choose their favorite from the top 2 firms to reach a majority.
- Final Board vote to approve the rank order of architectural firms interviewed for Library projects and to authorize Celeste to negotiate a contract with the highest-ranked firm.
- In the event that an agreement can't be reached with the highest-ranked firm, Celeste will move on to negotiate a contract with the second-ranked firm.

January 10, 2023 Board Meeting: Board votes whether or not to approve the negotiated contract with the highest-ranked firm.

Mid-January 2023: If contract approved, work begins.

Overview:

- This year's Summer Reading was organized around the theme "Read Beyond the Beaten Path."
- Even though staffing constraints reduced the Library's outreach efforts at the beginning of Summer Reading, most ages' registration numbers are close to those in 2021. Due to a successful partnership with Leal Elementary School, who had 80 K-5 summer students complete Summer Reading, the number of children who participated was higher than last year due!
- Other noteworthy findings in our Summer Reading stats include the highest completion rate we've recorded in the past six years at 68.27%.

- We use the percent of participants who logged reading and also completed Summer Reading to measure participant engagement. Over the past few summers, staff have been experimenting with Beanstack suggestions to increase engagement. Our efforts have paid off. This year the percent of participants who logged and then finished the program was over 80% for all ages! For comparison, the following table lists the percentage for the past three years. With this success, our focus for next year will turn to increasing registration.



Hello again! It feels like I was just writing to you and wishing you a safe and joyful summer and BOOM, more than three months have passed and here it is already a new school year!

This time of year is often exciting for young people, but for our youth, a new school year can bring out nerves and anxiety. That used to be true for Tony*, but thankfully it isn't anymore. In fact, there has been a lot of positive changes in Tony's life over the last several weeks. And now, he is at a new school, in a new town, with a new family and we couldn't be happier for him.

Tony came to Cunningham last summer after his adoptive parents surrendered their parental rights. Having lived in an unhealthy and negative environment, Tony had low self-esteem. He didn't believe he had value, anything to offer or that things were ever going to get better. Over time at Cunningham, Tony began to feel good about himself and have a better outlook on his life.

"I think what happened for him here at Cunningham is that he got accepted for himself," Cunningham's Chaplain Gay King Crede said. "He was feeling really bad about himself and about what happened to him, but our staff and the other youth were saying positive things about him and he really embraced that. He is such a sweet kid, and everybody just loves him."



Over the summer, our staff incorporate group and community activities into our kids' daily schedules which promote physical activity, social interaction, building independent life skills and learning how to access community services and resources. They focus on youths' individual interests and expand on that with activities they can participate in. One of these activities is the Teen Lab at the Urbana Free Library—a teen-directed space that promotes creativity, peer instruction, and community building. While Tony is social, creative, funny and popular among his peers, he had some apprehension when it came to the Teen Lab.

"Before Tony's first visit to the Teen Lab, he sat down with me and expressed his concerns over being in that environment around other kids," Mike, a Cunningham counselor, said. "We discussed how nervous he gets in those situations and how he struggles interacting with people, especially kids his age, that he doesn't know. I assured him that if he felt uncomfortable at any point, there were safe spots in the library he could stay while his peers were in the lab."

The Teen Lab is open to the public and on average, there are 5-15 youth there at a time. There are areas where youth can record music with keyboards, guitars, drums, computers; design objects and use an engineering software to print items

on a 3D printer; and play Wii and PS4 on the big screen. When playing video games, conversations about what is happening on the screen naturally occur which often lends itself to conversations about other things. Tony thrived in this environment.

"Tony ended up being one of the most social kids at the lab," Mike said. "He became more comfortable around new people, engaged in appropriate social interactions and was able to develop his social skills. I believe this experience will help him develop and engage in new relationships in his new school and other situations now that he has transitioned from Cunningham to a home setting."

Tony was elated to move in with his new foster parents, who are in the process of adopting him. When he left Cunningham in late July, he didn't have any fear he wouldn't be treated well by his new family. He feels at home and accepted there, and knows he has their unconditional love. That just makes my heart happy.

In the last fiscal year, 87% of our youth who transitioned from our Residential Treatment Center went to less restrictive settings, like living with a parent or relative, moving to a group or transitional living home or into foster care. This success wouldn't be possible without your support. Your contributions help provide for the resources that allow our amazing staff to offer our youth programming and education that promotes healing and learning.

You help us carry out this important work. As we start a new school year full of opportunities for growth, would you consider making another gift so young people like Tony can develop valuable social skills and confidence as they strive to find a new path for themselves?


