Biographical Note:

David High Loper, Jr. (1836-1915) and his wife, Sarah Van Hess Loper (1834-1900), relocated to Champaign County in 1856 from Philadelphia, Pennsylvania. Loper served as the constable for Champaign Township between 1870 and 1914. Among his duties was debt collection for area businesses and for the courts. Loper also owned land in Colorado, Kansas which was overseen by D.H. Hoyt.

D.H. and Sarah Loper had six children: William J. Loper (1854-1935); David H. Loper III (1856-1955); George Loper (1861-1944); Mary Etta (Marietta or Etta) Loper (1863-1955); Dr. Matilda Loper (1867-1947); and Eva Loper (1874-1946). William J. married and moved to California; Matilda was an osteopathic surgeon residing in St. Louis, Missouri. The other children remained in Champaign, at the family home at 209 W. Springfield, until their deaths. In their old age, John Tinkey provided live-in caregiving for Mary Etta and David H. Loper III; upon her death, he served as executor of Mary Etta's estate.

Scope and Content Note:

This collection contains records from D.H. Loper Jr.'s business as constable and debt collector of Champaign Township from the mid-1870s to 1913, primarily from the period of 1880-1890. Included are account receipts for collection and correspondence from business owners that used Loper's services, as well as accounting records kept by Loper. There is also a large collection of materials dealing with Loper's personal accounts, including insurance documents and correspondence regarding his Kansas property.

This collection also includes records from Loper's children, particularly Mary Etta and David H. Loper III. A large portion of the family papers includes the settling of the estate by John Tinkey after Mary Etta's death in 1955.
