**Biographical Note:**

Louis N. Bear was born on October 25, 1862. He attended the University of Illinois and founded Bear's General Store (Ludlow, Illinois) in 1882. He later turned the business over to his two sons in 1918. He served as Champaign County treasurer for a number of years and was recognized as the dean of the Champaign County Republican Committee. He died on April 19, 1951.

The Ludlow Building and Loan Association was founded in April 1888 and operated until at least 1904. Louis N. Bear served as secretary from 1888 to at least 1901, and as treasurer in 1898, and possibly other years.

**Scope and Content:**

This collection contains six ledger books of Bear's General Store dating from 1893 to 1906. Also contains a book from the Ludlow Building and Loan Association containing minutes from 1888 to 1901, and financial statements dating from 1890 to 1904.
